"Long ago, at many times and in many ways, God spoke to our fathers by the prophets, but in these last days He has spoken to us by His Son." (Hebrews 1:1-2)

**Trinity Lutheran Church Council Meeting
December 2, 2025**

Present: Pastor Hojnacki, Ken Fehr, Mark Liefer, Kathy Nagel, Dean Schoenbeck, Roger Liefer, Cliff Harms, Michael Koester, Danny Salger, and Lori Woods.

Opening: Chairman Ken Fehr called the meeting to order. Pastor led us in prayer.

Secretary's Report: The minutes were sent out to the board. With no changes or corrections, the minutes were approved.

Treasurer's Report: Dean reported that \$54,355 was collected for the Thanksgiving debt reduction. This was a good amount, but it did not cover our current debt of almost \$64,000. With additional expenses in November, we will only be able to pay off \$40,000 of the loan from Dieterich Bank. The carry out chicken soup netted \$3,805. We have exceeded our Mission Budget of \$15,000 by \$3,600. A motion was made, seconded and moved to accept the treasurer's report. Dean commented that most years our thanksgiving debt offering exceeds our debt, but this year it did not. Mark commented that this is a concern for the future of our school, with constant rising prices, and to keep good teachers, we need to have a plan. He just sent a letter to the church's that are in the COSLHS Association, asking that since COSLHS has closed, if they would consider supporting our mission here at Trinity School. Our school is important to our church families, but it's especially important to those unchurched families who are sending their children here, that we spread the love and grace of Christ to those children and their families. We have a mission right here. As discussed at the last meeting, a ballot vote will be presented at the annual voters meeting on whether we want to again set the mission budget at \$15,000. But this year, we propose that \$10,000 will again be designated for the SID and the other \$5,000 to pay for teachers' salaries here at Trinity.

Pastors Report: Pastor reported that attendance was varied, All Saints Day there were 178, and Thanksgiving Day there were 149 in attendance. The other weekends averaged about 120. In official acts, there was one baptism, Eleanor Zipfel, daughter of Lydia Mehring and Jason Zipfel on November 15. And one funeral, Rollie Dannenberg on November 23. The annual meeting is upcoming on Sunday, January 18. The following positions will need to be voted on, secretary, treasurer, trustees, elders, finance committee, and school board. If anyone would be willing to serve, please contact Ken Fehr.

Principal Report: Robin was unable to attend, but Pastor gave her report. Jeff Ficks, Southern Illinois District School Executive, visited our school and was impressed with our teachers and students. Police training for staff took place on Tuesday, Nov. 18. They discussed different lock-down procedures. Both girls and boys' basketball parent nights were held recently. The school board and staff will have a Christmas party on Dec. 19th. The School Board presented a check for \$5,000 for the debt reduction, which came out of the school activity fund (This was not included in the debt reduction number above). In addition, for all school fundraisers, the school donates back to the church at least 10%.

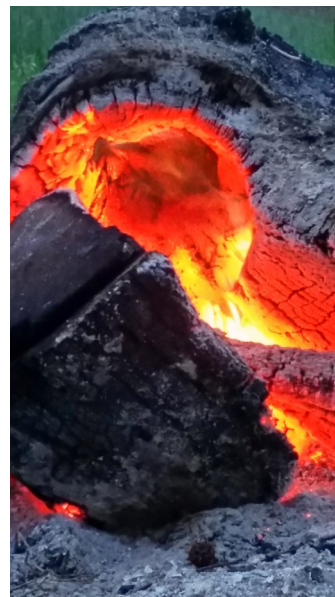

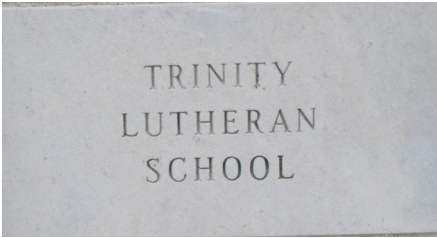

We have 2 BOCE members whose term is expiring and we have 3 new candidates to be put on the ballot for the January election.

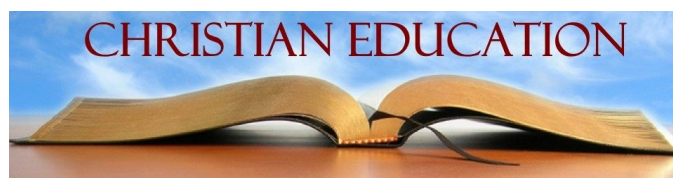
Looking ahead to the January meeting, we will set a date for the Kindergarten round up/Open house.
